Hartselle Junior High School Cheerleader Constitution

Effective March 1, 2020

I. Requirements for Tryouts/Participation

To be eligible to participate in the pre-tryout clinic and tryouts for HJHS Cheerleader, you must meet the following requirements:

A. At time of tryouts, you MUST have passing grade after 2nd 9-weeks in every class.

B. To cheer you must meet Alabama High School Athletic Association (AHSAA) guidelines.

C. Be free of any Class II or Class III conduct violations, as well as have no suspensions for the current academic year.D. Have not been removed or quit a cheer squad during the previous year.

E. May not be or become pregnant.

F.Have all required forms signed and returned to coach by Monday, March 11th. The required forms are as listed:

- 1. Physical Examination Form (due by the end of May)
- 2. Proof of Insurance (copy of card—front and back)
- 3. Handbook Agreement Form
- 4. Cheerleader Information Form
- 5. Medical Treatment Permission Form

II. Expenses

To cover the costs associated with tryouts, a \$20 tryout fee will be charged, and is due on the first day of the clinic. Please make checks payable to Hartselle Junior High School.

Attached you will find the <u>estimated</u> costs for 2020-2021. <u>Camp</u> <u>costs will be due to Hartselle High School</u> (the high school will be

helping us with camp) and should not exceed \$50.00 , **excluding** spending money, and/or camp attire.

All money for cheer camp will be due on March 27, 2020. The representative from Varsity, Inc. will conduct fittings on March 28, 2019. (Our time slot is tentatively 6:00. <u>THIS CAN CHANGE!!!</u>). Please see the estimation of costs.

Parents will receive a detailed bill of their child's expenses after the Varsity, Inc. uniform/camp clothing order. Parents MUST sign the bill to approve for order. Uniforms/cheer items will not be given out until bill is **PAID IN FULL**.

III. General Rules and Regulations

A. Cheerleaders must display qualities of good citizenship, sportsmanship, and loyalty to Hartselle Junior High School at all times.

B. Cheerleading MUST come before all other extracurricular activities, including jobs during football/basketball seasons.

C. Each cheerleader is required to have family insurance and provide a copy of insurance card prior to tryouts.

D. Cheerleaders must attend and be on time for every event, practice and game. Each cheerleader is responsible for arranging transportation to and from activities, practices, and games unless otherwise specified by the coach or school principal.

E. Cheerleaders will meet and ride with parents to most games. They may not ride with the coach. **We only attend home games for both football and basketball seasons.** We may attend a few close games at the coach's discretion.

F. A cheerleader will be dropped from the squad when his/her conduct brings embarrassment to himself/herself, the squad or school. The dismissal will occur upon the recommendation of the coach and/or principal. Any cheerleader who is removed or quits will still be responsible for any bills incurred and will have their picture and name removed from the cheerleader section of the yearbook. G. Cheerleaders must pay all expenses by due date and fulfill all duties connected with pep rallies, fundraising, ball games, and any other project the squad takes on as a group.

H. Attendance at practice is required, including cheerleading athletics period. Attendance at summer camp is also required or will be dismissed from the squad. Attendance at all games is required.

J. Any absence **MUST be approved by coach in advance.** Failure to do so will result in the cheerleader being benched and/or suspension. Excused absences will be determined by the coach and/or principal.

K. All appointments such as doctor, dental, etc. should be made around the cheer schedule and cheer athletics time <u>if at all possible</u>.

L. Cheerleaders MUST have knowledge of the sports for which he/she will cheer and be able to keep up with games.

M. Cheerleaders must wear hair in full ponytails at practice and games.

N. Fingernails must be kept at reasonable length for safety reasons. Also, polish should be clear—no exceptions.

O. Parents/guardians must understand that the coaches and principal have full authority to make decisions regarding the cheerleading program at Hartselle Junior High School. **These decisions must be respected and supported 100%.**

P. Cheerleaders must be in town and able to practice beginning August1. Family vacations must be made after summer camp and before this date.

Q. Cheerleaders who do not drive must have rides to pick them up <u>immediately</u> after practices, games, and other activities. We cannot leave until your child is picked up, which can cause us to be late picking up our own children. Please be respectful of our time.

R. If a cheerleader is not physically able to participate in an event, a physician's note/athletic trainer's note MUST be presented to coach. A note from the physician and/or athletic trainer must also be presented in order to return to full participation.

S. Cheerleaders who have recurring injuries may not be able to cheer due to the possibility of a more serious injury occurring. In the best interest

of the physical health of the cheerleader, recurring injuries may result in removal from the team.

Any situation not listed in this constitution will be handled on an individual basis. Any situation that arises will be handled by the coach and/or principal on an individual basis.

IV. Appearance (failure to comply will result in benching and/or suspension.)

A. Cheerleaders must be aware of their appearance at all times including games, practices, community involvement, and the regular school day.

B. School clothes should be modest and meet dress code.

C. Uniforms MUST be clean and pressed at all times.

D. Shoes MUST be cleaned after each game as needed. DO NOT wear dirty shoes to a game.

E. NO jewelry may be worn at practice or at games. (no exceptions)

F. Cheerleaders may not wear fingernail polish while in uniform unless it is clear polish.

G. A cheerleader may not have a visible tattoo.

H. The coach reserves the right to require cheerleaders to conform their appearance within reason if it becomes distracting or inappropriate.

I. If a cheerleader receives in-school-suspension on a game day, he/she will not be permitted to cheer <u>at all</u> for that particular event.

J. If a cheerleader is suspended, he or she will miss all

practices/games/cheer events for the duration of their suspension.

K. A cheerleader may not participate in games if not at school that day.

Coaches expect your daughter to be responsible. It is their responsibility to keep parents informed throughout the year.

Academics MUST come first. No cheerleader will be permitted to cheer if his/her grade falls below a 60 in any class at any time. A written note, email or phone call from his/her teacher stating their grade has improved will be necessary for them to return. A cheerleader will be benched 3 weeks if he/she has an "F" on their report card in any class. Also a cheerleader is not allowed to cheer if on the ICU list and will not be permitted to cheer until they are removed from ICU.

We will not be trying on used uniforms at cheer fittings. The coaches will not be responsible for any used uniform purchases. This must be done on your own.
